**COVID 19 POLICY UPDATE:
RESIDENTS, VISITORS AND SERVICE PROVIDER**

PLEASE READ CAREFULLY

Residents we ask that you and your visitors adhere to the following procedures:

1. **All visitors, residents and service providers** must wear face masks while present in any of the common areas of the community, including entrances and exits, lobby and hallways, elevators, stairs and public restrooms.
2. **All visitors, residents and service providers** must keep at least 2 metres apart from any other person(s) in the common areas whenever possible.
3. Elevator Use – Avoid Overcrowding - please limit amount of people in a car to a maximum of 4.
4. **Any visitors, guests or service providers** that are laboratory-confirmed or experiencing COVID-19 symptoms, including a fever, cough, respiratory ailment, loss of taste or smell, headaches, vomiting or diarrhea, muscle aches or other flu-like symptoms, are not to enter the condominium.
5. **Visitors and Service Providers** are required to sanitize their hands before entering the building(s) and using common spaces.
6. All visitors understand that by entering the building, they affirm that they are not COVID-19 positive and are not experiencing any symptoms.

Any entrant or occupant of these premises acknowledges that they understand and appreciate both the known and potential risks of entering these premises and utilizing the facilities thereof, and acknowledges that use thereof may result in exposure to COVID-19, despite reasonable efforts to mitigate such dangers and maintain the premises in a safe condition.

Note it is impossible for to disinfect all surfaces in a manner to totally eradicate the potential spread of COVID-19.

It is highly encouraged that residents continue to follow AHS guidance, including maintaining personal social distancing, washing/sanitizing your hands.

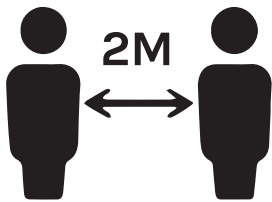

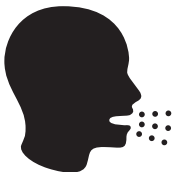
